Pursuant to the Federal Register Notice in this matter, 79 FR 71984 (December 4, 2014), and Rule 1010.4 of Bonneville Power Administration's (BPA's) Procedures Governing Bonneville Power Administration; Rate Hearings, 51 FR 7611 (March 5, 1986), the Pacific Northwest Generating Cooperative and its 14 members (collectively, the "PNGC Group") respectfully submit this Petition to Intervene in this docket and to participate jointly and collectively as a Party.

3. The PNGC Group has the following interest in the proceeding. Pacific Northwest Generating Cooperative is a cooperative corporation organized under the laws of the State of Oregon and is a Joint Operating Entity pursuant to the Northwest Power Act, 16 USC § 839(c)(b)(7). It will purchase power from BPA Power Services under a Contract High Water Mark Contract to meet the needs of the utilities that will be its members during the FY 2016-2017 rate period. The proceeding will materially and substantially affect BPA's rates for power. Therefore, as preference power customers of BPA, the PNGC Group claims a direct and substantial interest in this proceeding.

4. In addition, the proceeding will materially and substantially affect rates for transmission services. The Pacific Northwest Generating Cooperative and its members will purchase transmission service from BPA Transmission Services during the FY 2016-2017 rate period. Therefore, as transmission customers of BPA, the entities in the PNGC Group claim a direct and substantial interest in this proceeding.

5. No other Party may adequately represent the PNGC Group's interests in this proceeding.

6. Although not required by either the Federal Register Notice or the Procedures Governing Bonneville Power Administration Rate Hearings, the joint and collective representation of the interests of the Pacific Northwest Generating Cooperative and of its

members will avoid duplication of effort and aid in the efficient administration of this proceeding.
