8 Pursuant to the notice appearing in the Federal Register on November 10, 2016,
9 regarding the Bonneville Power Administration's ("BPA") Fiscal Year 2018-19 Proposed
10 Power and Transmission Rate Adjustments (81 Fed. Reg. 78999) and Section 1010.4 of
11 BPA's Rules of Procedure Governing Rate Hearings, Calpine Corporation ("Calpine")
12 respectively petitions for intervention as a party in Docket No. BP-18.

13 In support of this request, Calpine states as follows:

14 **I. PETITION TO INTERVENE**

15 Calpine operates the Hermiston Power Plant, a thermal generating facility located
16 in Hermiston, Oregon. Calpine is a BPA transmission customer, holding a significant
17 amount of Long-term, Firm, Point-to-Point Transmission Service on the BPA system. As
18 such, Calpine has a direct interest in all issues that do or could affect its transmission rate
19 levels or terms of service. Calpine's interest cannot be adequately represented by any
20 other party.




