**PETITION TO INTERVENE AS A PARTY OF
TRANSMISSION AGENCY OF NORTHERN CALIFORNIA**

Pursuant to Section 1010.6 of the Bonneville Power Administration’s (“BPA”) Rules of Procedure Governing BPA Proceedings and the notice published in the Federal Register on December 6, 2018, 83 FR 62849 (2018), the Transmission Agency of Northern California (“TANC”) submits this Petition to Intervene as a party in this proceeding.

I. PETITION TO INTERVENE

TANC is a joint exercise of powers agency organized and existing under the laws of the State of California and is a “municipality” as defined in Section 3(7) of the Federal Power Act, 16 U.S.C. § 796(7) (2012). Among TANC’s purposes is the provision of electric transmission facilities and services for the use of its Members.¹ TANC is the largest Participant in, and the Project Manager of, the California-Oregon Transmission Project (“COTP”), a 500 kV transmission project extending from the California-Oregon border to near Pacific Gas and

The Plumas-Sierra Rural Electric Cooperative is an associate member of TANC.

Electric Company's ("PG&E") Tesla Substation in central California. The COTP is part of the high voltage facilities that comprise an electrical path spanning the Pacific Northwest and northern California. Energy flowing to or from the BPA transmission system may utilize the COTP for transactions involving California.

The BP-20 rate proceeding will establish, among other things, power and transmission rate adjustments for power, transmission, ancillary, and control area services rates for the FY2020-2021 rate period. These rates may effect transactions involving the COTP and the BPA transmission system. In addition, as a petitioner (along with TANC Members SMUD and Turlock) to a pending appeal in Ninth Circuit Case No. 18-71753 pertaining to BPA's approval in BPA Docket No. BP-18 of rates for hourly transmission service on the Southern Intertie, TANC has a particular interest in the Southern Intertie hourly rates proposed in the BP-20 proceeding. Accordingly, TANC has a substantial interest in this proceeding because it will be directly and substantially affected by any determination regarding the proposed rates. No other party can adequately represent TANC's interests in this proceeding. TANC, therefore, has good cause to intervene in the BP-20 proceeding, and such intervention is in the public interest.
