**PETITION TO INTERVENE OF
EDP RENEWABLES NORTH AMERICA LLC**

EDP Renewables North America LLC (“EDPRNA”), on behalf of itself and certain subsidiaries, files this Petition to Intervene in the above-captioned matter as a party with full rights pursuant to Rule 1010.6 of the Rules of Procedure of Bonneville Power Administration (“Bonneville”) governing rate hearings and the December 1, 2020 *Federal Register* notice published at 85 Fed. Reg. 77,189. EDPRNA respectfully requests that it be granted full party status in Bonneville Docket No. BP-22, including any related sub-dockets (“Proceeding”). In support of this Petition, EDPRNA submits the following information:

I. Petition to Intervene

EDPRNA and its subsidiaries, Arlington Wind Power Project LLC (“Arlington”), Sagebrush Power Partners, LLC (“Sagebrush”) and Wheat Field Wind Power Project LLC (“Wheat Field”) are long-term transmission customers under Bonneville’s Open Access Transmission Tariff.¹

Accordingly, EDPRNA has a direct and substantial interest in the outcome of this Proceeding that cannot be adequately represented by any other party. Therefore, EDPRNA
