Pursuant to the notice appearing in the Federal Register Vol. 88, No. 214 / Tuesday, November 7, 2023, TransAlta Energy Marketing (U.S.) Inc. (“TEMUS”) respectfully petitions to intervene as a party in this proceeding. TEMUS’ concerns relate to the Bonneville Power Administration’s (“BPA”) proposed modifications to the non-rate terms and conditions of the open access transmission tariff (“OATT”). In support of this request, TEMUS states as follows:

I. PETITION TO INTERVENE

TEMUS is a corporation organized under the laws of the State of Delaware, with an office in Portland Oregon, head office in Calgary, Alberta, Canada and electric generation facilities in the State of Washington. This proceeding concerns changes to terms and conditions in BPA’s OATT, which apply to TEMUS when it maintains its interconnection to the BPA system and submits new applications for interconnection. As TEMUS is directly and significantly impacted by this proceeding, and its interests cannot be adequately represented by another party, it respectfully requests that it be allowed to intervene as a party.
