**Petition to Intervene of Avista
Corporation**

Pursuant to the notice posted in the Federal Register on November 7, 2023, regarding the Bonneville Power Administration (“BPA”) Proposed Modifications to Open Access Transmission Tariff; Public Hearing and Opportunities for Public Review and Comment, 88 Fed. Reg. 76744 (2023), Avista Corporation (“Avista”) hereby files this Petition to Intervene as a party in these proceedings. Avista requests that it be granted party status in BPA Docket No. TC-25, including any subdockets to that proceeding.

I. Petition to Intervene

BPA is holding a proceeding, Docket No. TC-25, to modify the non-rate terms and conditions for transmission and interconnection services in its open access transmission tariff. Avista is a corporation created and organized under the laws of the State of Washington, with its principal office at 1411 E. Mission Ave., Spokane, Washington. Avista is an investor-owned utility engaged in among other things, the business of generating, transmitting, and distributing electric power to wholesale and retail customers in Idaho and Washington. Avista is a transmission customer of BPA. Accordingly, Avista has an interest in these proceedings and is eligible to be a party in this proceeding. *See* 88 Fed. Reg. at 76746-76747. Avista’s interests will not be

represented adequately by any other party. Avista respectfully requests that it be allowed to intervene as a party in the above-captioned proceedings.
